Complete this form to apply for a Certificate of Arkansas Ancestry, a form of recognition for the descendants of Arkansas settlers in four categories: **Colonial** \_\_\_ a resident of Arkansas before 1 January 1804; **Territorial** \_\_\_ a resident of Arkansas before 15 June 1836; **Antebellum** \_\_\_ a resident of Arkansas before 6 May 1861; **Nineteenth Century** \_\_\_ a resident of Arkansas before 31 December 1900. The category in which the certificate is issued will depend upon the proof of residency document submitted with this application.

Applicants must submit: ( 1 ) proof of direct descent from an ancestor who resided in Arkansas in the period of the category claimed; ( 2 ) a family group sheet for the ancestor for whom the certificate is claimed; ( 3 ) a photocopy of an original document proving Arkansas residency for the ancestor; ( 4 ) a check or money order in the amount of \$10.00 for the certificate. Submit one application for one certificate. If you need additional applications for other ancestors, photocopy this form or order from the AGS certificate chairman.

## **Directions to Complete the Forms**

Please read the entire form before completing it.

Make a photocopy of the form for future use or to have a working copy before submitting the completed form to AGS.

Type or print clearly in black ink.

Record dates as "4 Nov 1842" in the form.

Write place names with the locality, county and state; i. e., Washington, Hempstead Co, AR.

Use maiden names for all the women. If the maiden name is not known, do not write a last name for her.

All of the blanks on these forms need not be completed in order for the application to be accepted, but enough information must be supplied to confirm the lineage and sufficient information must be provided on the family group sheet to establish the identity of the ancestor.

Send legible photocopies of all the documents. Do not send an original. Do not write on the front of the photocopies or alter them. On the reverse of the photocopy, write your name and address with the complete reference or citation on where the document can be found. If it requires further explanation, attach a sheet with your reference.

Retain a photocopy of all the completed application and any attachments for your personal needs.

If any of the information in the lineage, family group sheet or proof documents cannot be verified or is unclear, you will be contacted and given an opportunity to clarify and/or support your information.

If you have not received your certificate or correspondence from AGS within eight weeks, please write or inquire about the status of your application.

**Directions:**

Read the general directions on page 2 first.

Start with yourself as Number 1 and work backward to your ancestor through whom you are applying for a certificate. If you are applying for a certificate in your child's name, list the child as Number 1 and yourself or your spouse as Number 2. You may continue to list your lineage back as far as you know it, past the first Arkansas ancestor.

If you need space for more generations than those on this application form, use this same format and write on blank sheets and enclose them.

If you do not have the exact dates of births, deaths and marriages, use approximate dates from the source materials you have found. Use "abt" or "circa".

List the documents or evidence you have which prove the facts about each ancestor's life and which prove the links between parents and children. Examples of source citations are: "Marriage Book B, page 213, Stone County, Arkansas" or "1900 Census, Stone County, Arkansas, Clay Township, ED #47, household 72" or "Family Bible in possession of Mrs. John Smith, 123 Main Street, Little Rock, Arkansas, 72212". The citation should make it easy for the source to be traced.

A death certificate that lists the birthplace as Arkansas will not be considered primary evidence for the birth. An 1850 census record, however, showing the birthplaces of children as Arkansas may be considered valid evidence of earlier residency.

Examples of acceptable documents include: tax lists, court, military, church and census records, petitions, newspapers items, land patents and others.

Similarity of name alone is not sufficient for identification. If there is some question about the proof document, a letter of inquiry will be sent to the applicant.
